DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE GLADES PHASE III

(SECOND SUPPLEMENTAL DECLARATION OF RESTRICTIONS FOR THE GLADES

WHEREAS, Edgewater Estates, Inc., the original developer of the Glades, (the "Developer"), owns certain land in Bay County, Florida and has created the Glades Phase III, a single family residential development consisting of thirteen (13) single family lots as an unrecorded subdivision the (the "Lots");

WHEREAS, Developer desires to submit the Lots to the jurisdiction of THE GLADES OWNERS ASSOCIATION, INC. (the "Association"), a non-profit Florida corporation maintaining and administering the common properties and facilities and administering and enforcing the covenants and restrictions of The Glades pursuant to a certain Declaration of Covenants and Restrictions for The Glades executed and recorded in Official Records Book 1247, Page 928 of the Public Records of Bay County, Florida, re-recorded in Official Records Book 1247, Page 1577 of the Public Records of Bay County, Florida, and amended in Official Records Book 1300, Page 1951 of the Public Records of Bay County, Florida (herein collectively referred to as the "Glades Declaration");

WHEREAS, according to the provisions of Article II of the Glades Declaration, the Developer reserved the right to file or record Supplemental Declarations from time to time adding property then owned by Developer in Bay County, Florida to the scheme of the Declaration and to subject it to the jurisdiction of the Association and the Developer may do so in its sole discretion;

WHEREAS, the Association's Board of Directors has unanimously endorsed the Developer's submission of the Lots to the jurisdiction of the Association.

NOW, THEREFORE, the Developer hereby declares that the real property described in Exhibit A attached hereto is and shall be held, transferred, sold, conveyed, leased, occupied and used subject to the easements restrictions, covenants, charges, liens, conditions and affirmative obligations which are contained, embodied and set forth within the Glades Declaration and any and all subsequent amendments thereto and shall further be subject to the conditions and affirmative obligations of this Declaration of Covenants and Restrictions for the Glades Phase III.

Section 1. Existing Property. The real property which is held, transferred, sold, conveyed and occupied subject to this Declaration is located in Bay County, Florida and is more particularly described in Exhibit A, attached hereto.

Section 2. Submission to Glades Declaration. Effective January 2, 2002, the real property of the Developer described in Exhibit A attached hereto is submitted to the provisions of the Glades Declaration for the purposes of protecting the value and desirability of such real property, and the provisions of the Glades Declaration shall run with such real property and shall be binding upon all parties having any right, title or interest in the real property described in the Lots or any portion thereof, their heirs, successors and assigns forever, and shall inure to the benefit of each owner thereof. The Lots shall be included within Block G of the Glades and numbered as referenced in Exhibit A.

Section 3. Additional Covenant for Phase III Assessments.

A. The Developer, for each Lot owned by it, hereby covenants, and each Owner of any Lot, by acceptance of a deed therefore, whether or not it shall be so expressed in any such deed or other conveyance, shall be deemed to covenant and agree to pay to the Association the maintenance assessments levied by the Association pursuant to Article V of the Glades Declaration, currently set at \$172.50 annually per Lot.

B. In addition to such maintenance assessments, the Developer, for each Lot owned by it, hereby covenants, and each Owner of any Lot by acceptance of a deed therefore, whether or not it shall be so expressed in any such deed or other conveyance, shall be deemed to covenant and agree to pay to the Association the assessments made by the Association for the maintenance of the storm water management system located on the Lots.


